ORDER GRANTING MOTION FOR ADMISSION PRO HAC VICE OF DARI R. DORNAN

This matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. Having reviewed the pleadings and record, the Commission makes the following findings:

- 1. On January 8, 2019, the Commission opened a general investigation to determine the appropriateness of accepting irrevocable letters of credit in place of cash deposits.¹ All Kansas gas and electric public utilities were made party to the general investigation.²
- 2. On January 14, 2019, Dari Dornan entered her appearance in this Docket on behalf of Black Hills/Kansas Gas Utility Company, LLC d/b/a Black Hills Energy (Black Hills).³
- 3. On February 19, 2019, James G. Flaherty, an attorney for Black Hills Energy, licensed to practice law in the State of Kansas, filed a Motion for *Pro Hac Vice* Admission of Dari R. Dornan, pursuant to Kansas Supreme Court Rule 116. The *Pro Hac Vice* Motion includes the required Verified Application signed by Ms. Dornan.
