
2. The Commission made CURB a party to this docket to be served with copies of entries of appearances, comments, forms, and pleadings.

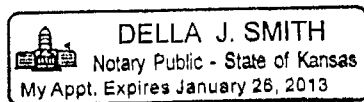


