## PREHEARING OFFICER ORDER REGARDING ELECTRONIC SERVICE

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed the pleadings and record, the Prehearing Officer makes the following findings:

- 1. On February 8, 2019, Berexco LLC filed an application for an order authorizing the unitization and unit operation of the Arroyo Unit in Stanton County, Kansas, pursuant to K.S.A. 55-1301, et seq.<sup>1</sup>
- 2. At an April 25, 2019, prehearing conference, all parties consented to the electronic service of all documents<sup>2</sup> and orders.<sup>3</sup> Therefore, the Prehearing Officer directs that service of all documents and orders may be made by email. To the extent that it is practicable, any electronically served document or order shall be attached to the email and served in pdf format.
