- 3. On December 4th, 2019, Evergy filed a Motion to Withdraw Application and Close Docket in light of the changes mentioned above.
- 4. Since the project has been cancelled, Staff agrees it is the correct course of action to close this docket and allow Evergy to withdraw its Application.

A. Evergy's Motion to Withdraw Application and Close Docket is approved.

- C. The Commission retains jurisdiction over the subject matter and the parties for the purpose of entering such further order or orders, as it may deem necessary.
