ORDER GRANTING JOINT MOTION FOR PROCEDURAL SCHEDULE

This matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. Having reviewed the pleadings and record, the Commission makes the following findings:

1. On February 9, 2018, Kansas Power Pool (KPP) filed an Application for a Transmission Rights Only certificate of public convenience and necessity. On May 8, 2018, KPP triggered K.S.A. 66-131's 180-day statutory clock, by filing Larry Holloway's testimony.

2. On May 14, 2018, KPP, Southern Pioneer Electric Company,¹ Mid-Kansas Electric Company, Inc.,² and Commission Staff filed a Joint Motion for a Procedural Order.

3. After reviewing the Joint Motion, and in collaboration with the Joint Movants, the Commission adopts the following procedural schedule:
