
Dear Ms. Chaney-Tucker:

On June 20, 2024, the Commission approved Atmos Energy's application for approval to rename the "commodity charge" in its tariffs to "delivery charge." Atmos Energy has discovered that when it submitted its tariffs for approval of the name change, it included the incorrect delivery charge in the Interruptible Transportation Service (Rate Schedule IT900) for Ccfs greater than 20,000 as \$0.07970, when the correct delivery charge should have been \$0.07670. Atmos Energy has confirmed the correct charge has been assessed to customers. However, Atmos Energy would like to remove the incorrect tariff sheet and replace it with the correct tariff sheet.

Attached is a red-line and clean copy of the tariff sheet showing the above-mentioned correction.
