**MOTION FOR EXTENSION OF PROCEDURAL ORDER**

COMES NOW Southern Pioneer Electric Company (“Southern Pioneer”) and hereby moves the Commission for an Order extending certain dates in the procedural schedule in the above-captioned matter. In support of its motion, Southern Pioneer states the following:

1. On June 25, 2024 Southern Pioneer filed a motion for procedural schedule, which was granted on July 9, 2024 and resulted in the following procedural schedule entered in this matter:

2. After the technical conference, the parties agreed to exchange additional information, extend the date for Staff to file its R&R, and include a date for intervenors and other parties in addition to Southern Pioneer to file testimony related to Staff’s R&R.

3. The parties have discussed and agreed, therefore, that the date for Staff to file its R&R should be extended from July 10 until July 17, 2024. The parties have also agreed to extend the date for testimony to be filed in response to the Staff R&R until July 24, 2024. The remaining dates from the initial procedural order would remain the same.

WHEREFORE, Southern Pioneer respectfully requests the Commission grant this motion and extend the date for the Staff to issue its R&R until July 17, 2024, and extend the deadline for all parties to file responsive testimony to Staff's R&R until July 24, 2024.
