ORDER APPROVING AMENDED VIDEO SERVICE AUTHORIZATION

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and determination. Having examined its files and record, and being duly advised in the premises, the Commission finds and concludes as follows:

- 1. On August 15, 2023, S&T Communications, LLC, (S&T) filed an Amended Application (Application) for state-issued Video Service Authorization (VSA), as authorized by K.S.A. 12-2023 and K.A.R. 82-15-1.
- 2. K.S.A. 12-2023 authorizes the Commission to review applications for those entities desiring to provide cable or video services within the State of Kansas. Upon an applicant meeting all application requirements, the Commission will issue the requested VSA.
- 3. On August 30, 2023, the Commission Staff (Staff) submitted its Report and Recommendation, recommending the Commission grant S&T's Application requesting to expand its previously granted authority to include portions of Scott County, in the State of Kansas, including Scott City. An electronic version of the description was provided in a format compatible with the Commission's mapping system. Staff finds S&T's Application to be complete and in conformity with K.S.A. 12-2023 and K.A.R. 82-15-1. Staff observes that by

initialing its Application, S&T has previously agreed to comply with all applicable municipal regulations regarding the use and occupation of public rights-of-way in the delivery of video services, including the police powers of the municipalities in which the service is delivered. S&T has previously been granted VSA in ten (10) footprint areas in Kansas.

- 4. Staffs Report and Recommendation confirms that S&T is registered with the Kansas Secretary of State's office as a Kansas limited liability company and that its current status with that office is active and in good standing.
- 5. According to Staff, S&T is properly registered with the Federal Communications Commission (FCC) for its proposed service area and provided the following Community Unit Identification (CUID) information:

- 6. Utilizing a combination of services, S&T will be capable of providing video service to households within its proposed footprint within the required five-year deployment window.² By initialing, S&T has previously agreed that it will not deny access to service to any group of potential residential subscribers because of the income of residents in the local area in which such group resides.³
- 7. Staff recommends Commission approval of S&T's Application to amend its Video Service Authorization to include the service areas of the portions of Scott County in the State of Kansas.
 - 8. The Commission concurs with Staffs analysis and recommendation of

August 30, 2023, which Report and Recommendation is attached to the Order and incorporated by reference, and finds that S&T's Application should be granted, approving the request to

expand its service area footprint to include portions of Scott County in the State of Kansas.

The Application of S&T Communications, LLC, for state-issued Video A.

Service Authorization is hereby granted and the requested expansion of S&T's service area

Order.

EXECUTIVE SUMMARY:

On August 15, 2023, S&T Communications, LLC (S&T) filed an Amended Application for state-issued Video Service Authorization (VSA), as authorized by K.S.A. 12-2023 and K.A.R. 82-15-1. Staff recommends approval of this Application.

Per K.S.A 12-2023(a), Commission action in this matter is required not later than September 14, 2023.

BACKGROUND:

The Applicant, S&T, holds a VSA granted by the Commission on October 11, 2018.¹ This Amended Application requests to add to the Company's footprint to include the City of Scott City in Scott County.

K.S.A. 12-2023 gives the Commission the authority to review applications for entities who desire to provide cable service or video service in the state of Kansas.

The Commission must review an application for VSA to determine whether the applicant:

1) identified the location of its principal place of business and the names of its principal

- executive officers;
- 2) filed or will file all forms required by the Federal Communications Commission (FCC) before offering video service in Kansas;
- 3) agreed to comply with all applicable federal and state statutes and regulations;
- 4) agreed to comply with all lawful and applicable municipal regulations regarding the use and occupation of public rights-of-way in the delivery of the video service, including the police powers of the municipalities in which the service is delivered; and
- 5) described the service area footprint to be served within Kansas and provided the period of time, not to exceed five years, in which the applicant will be capable of providing video service to all households in the service area footprint, and a general description of the type or types of technologies the applicant will use to provide the video programming.

These showings by the applicant are to be made in the form of an affidavit signed by an officer or general partner of the applicant. Upon proper showing, the Commission shall approve the VSA.

ANALYSIS:

S&T identified its principal place of business as 320 Kansas Avenue., PO Box 99, Brewster, Kansas, 67732, and did not provide any changes to the Company's key personnel contacts for Regulatory and Application matters.

The Applicant is properly registered with the Kansas Secretary of State's office as a Kansas Limited Liability Company. Its current status with the Secretary's office is Active and in Good Standing.²

The Applicant is properly registered with the FCC for its proposed service area and provided the following information:

By initialing, the Applicant previously³ agreed to comply with all applicable federal and state statutes and regulations and agrees to comply with all lawful and applicable municipal regulations regarding the use and occupation of public rights-of-way in the delivery of video services, including the police powers of the municipalities in which the service is delivered. The Applicant will provide services throughout the City of Scott City, a rural community in western Kansas, beginning November 1, 2023, and will pass all homes to offer services by October
