# CURB's Response to Westar Energy, Inc. and Kansas Gas and Electric Company's Motion For Approval of Energy Efficiency Budgets

The Citizens' Utility Ratepayer Board (CURB) files its response below to the *Motion For Approval of Energy Efficiency Budgets* of Westar Energy, Inc.'s and Kansas Gas and Electric Company (Westar), which was filed in the above-captioned docket on October 15, 2015:

1. CURB recommends the Commission deny Westar's *Motion For Approval of Energy Efficiency Budgets* as presented.

2. Westar's *Motion* requests approval of five-year budgets for four energy-efficiency programs. Westar's *Motion* fails to identify what portion, if any, of the five-year energy-efficiency program budgets should be considered interim. In its *Order on Operating Budgets and EM&V Studies* in Docket No. 15-WSEE-021-TAR, the Commission found that "(f)or programs offered during an evaluation process, Westar shall petition for approval of interim program budgets during the pendency of the evaluation."

3. Two of Westar's energy-efficiency programs – WattSaver and Energy Efficiency Demand Response – are undergoing Commission-ordered evaluations. According to Westar's *Motion*, 99% of the five-year, \$27,003,750 energy-efficiency budget is for the operation of the WattSaver and Energy Efficiency Demand Response programs.

4. Until the Commission-ordered evaluations for WattSaver and the Energy Efficiency Demand Response programs are complete, and the Commission has time to determine whether the programs should be continued and the appropriate budget level for each program, it is premature to approve five-year budgets as requested in Westar's *Motion*.

5. Therefore, CURB recommends that the Commission deny Westar's *Motion For* Approval of Energy Efficiency Budget.




