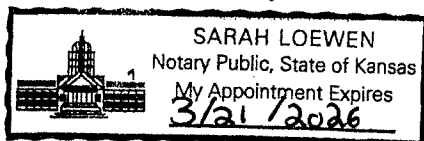

You, and each of you, are hereby notified that Scout Energy Management, LLC ("Applicant") has filed an Application with the Corporation Commission of the State of Kansas ("Commission") requesting Dissolution of the Basic Integrated Proration Order for the Hugoton Gas Field and Panoma Council Grove Gas Field ("BIPO"), said order governing gas production from said fields in Kearney, Finney, Grant, Haskell, Morton, Stevens, Seward, Stanton, Gray, Hamilton and Wichita Counties, Kansas.
