All Lifeline plans have at least 1,000 voice minutes, 1,000 text messages, and 458 of data. Due to support from the Kansas Universal Fund, Kansas Lifeline customers will receive 1,000 voice minutes, 1,000 text messages, and 668 of data and those residing on Tribal lands will receive unfilmate vioce minutes and text messages and 2,008 of data. There is only one monthly discount for Lifeline supported arrives per household, and it is true transferable to another person. You must use your Lifeline service at least once per 30 days, or you will be de-enrolled from the program. International/domestic reaming are not included. Not combinable with other offers.
