# KANSAS GAS SERVICE Annual Ad Valorem Filing

Kansas Gas Service, a division of ONE Gas, Inc. ("Kansas Gas Service" or "Company"), in compliance with the Commission's Order issued on July 14, 2004 in Docket No. 04-KGSG-1099-TAR ("04-1099 Order") respectfully submits its Annual Ad Valorem Filing. In support thereof, Kansas Gas Service states the following to the State Corporation Commission of the State of Kansas ("Commission"):

# I. DESCRIPTION OF KANSAS GAS SERVICE

1. Kansas Gas Service is a natural gas public utility operating in the state of Kansas pursuant to certificates of convenience and necessity issued by the Commission. #### III. NATURE OF FILING

3. K.S.A. 66-117(f) allows Kansas public utilities to file tariffs which collect ad valorem tax expense, and imposes certain obligations on Kansas public utilities with ad valorem tax riders. The Commission approved Kansas Gas Service's Ad Valorem Tax Surcharge Rider ("ATSR") in the 04-1099 Order.

4. K.S.A. 66-117(f) requires Kansas Gas Service to "report annually to the [Commission] the changes in expense charged for ad valorem taxes." The 04-1099 Order requires Kansas Gas Service submit annual ATSR true-up filings by December of each calendar year.

### IV. SUBMISSION

 Pursuant to the 04-1099 Order, Kansas Gas Service respectfully submits its annual ATSR true-up.

WHEREFORE, Kansas Gas Service, a division of ONE Gas, Inc., prays the Commission accept this filing and its associated attachments, find the filing compliant with the Commission's 04-1099 Order and K.S.A. 66-117(f), and so provide any other such relief as the Commission may deem just and reasonable.

Dear Mr. Rehagen:

The Commission's July 14, 2004, Order in Docket No. 04-KGSG-1099-TAR approved Kansas Gas Service's Ad Valorem Tax Surcharge Rider (ATSR). The order instructed KGS to file an annual true-up in December of each calendar year and charged Commission Staff with the review of the filing to ensure the surcharge's reasonable application and proper calculation.

This letter transmits the required true-up, including previously unrecovered Ad Valorem taxes charged to KGS plus the recently received 2024 assessments. We have calculated the 2025 surcharge to be charged to KGS sales and transportation customers, as specified under the ATSR. This filing recognizes current assessments from taxing jurisdictions and the corresponding tax expense being recovered in rates, as approved by the Commission in Dockets 18-KGSG-560-RTS and 24-KGSG-610-RTS. We expect to know a portion of the remaining assessments and the actual November 2024 recoveries by the time Staff completes their audit of our calculations, at which time any applicable updates can be made.

I have attached a pdf spreadsheet showing the calculation of the new surcharge to be reflected on customers' bills beginning with January 2025 cycle 1 billings; also attached is an itemized listing of taxes assessed by each taxing entity. We are providing the tax assessments received to date and will follow-up in early December with any outstanding assessments.


