The purpose of this filing is to make the following tariff changes:

- Business access line rate will increase by \$1.50 (Current access line rate is \$19.50 increasing to \$21.00)
- ExpansionPAK II (EPAK II) bundles will increase by \$2.50 (business access line rate increase of \$1.50 and intrastate long distance minutes rate increase of \$1.00)

A copy of the bill messaging that will be used to notify customers of these changes is enclosed for your reference. These bill messages will be delivered to customers as part of the June 16, 2021, billing cycle.
