RE: BlueRidge Petroleum Corporation - Application for an extension to the pit closure time requirement of K.A.R. 82-3-602 for the Olson #1-9 well located in Morris County, Kansas.

TO: All Oil & Gas Producers, Unleased Mineral Interest Owners, Landowners, and all persons whoever concerned.

You, and each of you, are hereby notified that BlueRidge Petroleum Corporation has filed an application for an extension to the pit closure time requirement of K.A.R. 82-3-602 for the Olson #1-9 well, located 2173' from the south line and 1997' from the east line, in the SE NW NW SE of Sec. 9-T14S-R8E, Morris County, Kansas. Said application requests that the earthen pits be allowed to remain open for an additional 270 day period to ensure they are thoroughly dried out before being filled in.

Any persons who object to or protest this application shall be required to file their objections or protest with the Conservation Division of the State Corporation Commission of the State of Kansas within thirty (30) days from the date of this publication. These protests shall be filed pursuant to Commission regulations and must state specific reasons why the grant of the application may cause waste, violate correlative rights or pollute the natural resources of the State of Kansas.



All persons interested or concerned shall take notice of the foregoing and shall govern themselves accordingly.
