The West 40 feet of a tract of land located in the Southwest Quarter (SW1/4) of Section 5, Township 10 South, Range 10 East of the 6th P.M., more particularly described as follows: Beginning at a point of intersection of the Southerly right-of-way line of Highway 24 and East line of said Southwest Quarter, said point being S.3°05'33" E. 61.60 feet from the center of said Section 5; thence S. 89°38'11" W. 1355.39 feet along the Southerly right-of-way line of said Highway 24 to an existing North-South fence; thence S. 3°05'33" E. 1293.42 feet parallel to the East line of said Southwest Quarter; thence N. 89°54'51" E. 1255.58 feet parallel to the North line of said Southwest Quarter; thence S. 3°05'33" E. 1292.72 feet parallel to and 100.00 feet from the East line of said Southwest Quarter to the South line of said Southwest Quarter; thence S. 39°55'21" E. 100.17 feet along the South line of said Southwest Quarter to the South Quarter Corner of said Section 5; thence N. 3°05'33" W. 2593.01 feet along the East line of said Southwest Quarter to the point of beginning, containing 43.27 acres, more or less.

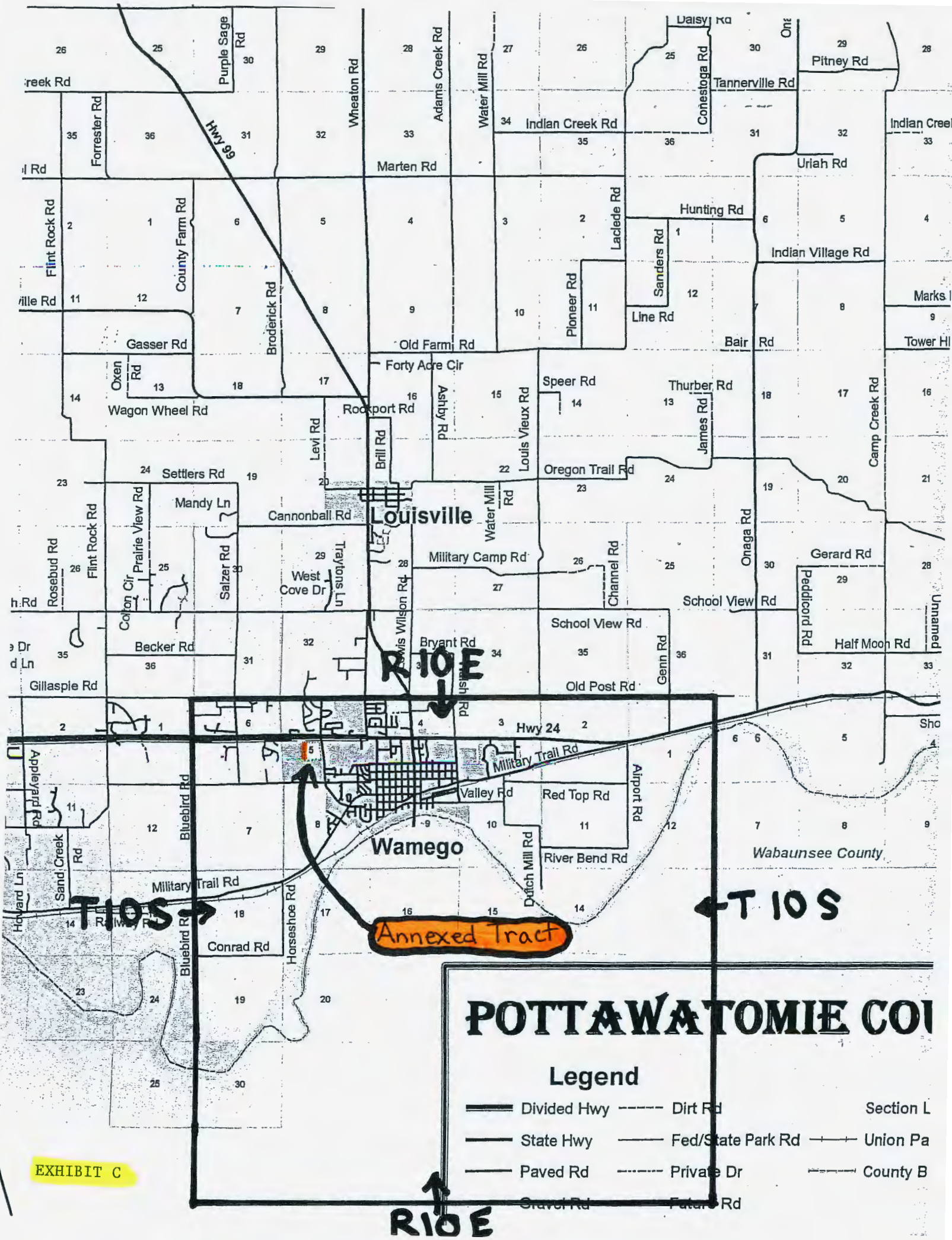
