**PREHEARING OFFICER ORDER REGARDING ELECTRONIC SERVICE**

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed the pleadings and record, the Prehearing Officer makes the following findings:

1.        On January 30, 2019, Hopper Oil Co., Inc. (Operator) filed an Application to amend injection permit E-17207, requesting to add the Hammer #10 well to the permit.<sup>1</sup> Cindy Hoedel filed a protest of the Application.<sup>2</sup>

2.        At a February 26, 2019, prehearing conference, all parties consented to the electronic service of all documents<sup>3</sup> and orders.<sup>4</sup> Therefore, the Prehearing Officer directs that service of all documents and orders may be made by email. To the extent that it is practicable, any electronically served document or order shall be attached to the email and served in pdf format. Service of orders is complete upon transmission.<sup>5</sup> Parties are encouraged to make sure large pdf files do not result in delivery failure and to work together to resolve any email-based service issues.

5. **The Prehearing Officer requests that any counsel filing a written entry of appearance in this docket, or any person making an initial filing in this docket, indicate in such filing whether such person consents to electronic service of all documents and orders.**
