ORDER CLOSING DOCKET

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and determination. Having examined its files and record, and being duly advised in the premises, the Commission finds and concludes as follows:

- 1. On May 13, 2009, the Commission issued an Order granting the March 27, 2009 Application of Southwestern Bell Telephone Company d/b/a AT&T Kansas (AT&T Kansas) and approving an Interconnection Agreement between AT&T Kansas and Trans National Communications International, Inc. n/k/a TNCI Operating Company, LLC (TNCI). Subsequently, on August 28, 2014, the Commission issued a second Order in the above-captioned docket granting AT&T Kansas' June 24 2014 Application requesting approval of a modification to AT&T Kansas and TNCI's Interconnection Agreement.
- 2. On February 26, 2018, AT&T Kansas filed a notice of termination of the Interconnection Agreement between AT&T Kansas and TNCI. AT&T Kansas' notice of termination states that the subject Interconnection Agreement, at the request of TNCI, was terminated by the parties on January 31, 2018.

3. The Commission accepts AT&T Kansas' February 26, 2018 notification of termination of the subject Interconnection Agreement and determines that the above-captioned docket should therefore be closed.

IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

- A. The Commission accepts the February 26, 2018 notice of termination of the Interconnection Agreement between Southwestern Bell Telephone Company d/b/a AT&T Kansas and TNCI Operating Company, LLC referenced in paragraph 1 above and this Docket is hereby closed.
- B. The Commission retains jurisdiction over the parties and the subject matter of this Docket for the purpose of issuing such additional orders as it may deem necessary.
