ORDER DESIGNATING PRESIDING OFFICER

This matter comes before the State Corporation Commission of the State of Kansas ("Commission") for consideration and decision. The Commission finds the following:

- 1. On August 6, 2024, the Commission issued an Order directing Vantage Point Solutions, Inc. ("VPS") to perform an audit of IdeaTek Telcom LLC's ("IdeaTek") Kansas Universal Service Fund ("KUSF") contributions and file its audit report no later than June 30, 2025.¹ The Order also directed IdeaTek to file its response to the report no later than thirteen (13) days from the date VPS files the audit report.²
- 2. On June 11, 2025, VPS filed its audit report of IdeaTek. Subsequently, IdeaTek filed its response to the audit report on June 24, 2025, and Commission Staff then filed a reply on July 3, 2025.
 - 3. On July 14, 2025, IdeaTek filed a Request for Hearing.
- 4. The Commission may designate a presiding officer to conduct prehearing conferences to address any matters appropriately considered in a prehearing conference, including all items listed in K.S.A. 77-517(b) of the Kansas Administrative Procedure Act
