The hearing will be formal in nature and will involve both the rules of civil procedure and the rules of evidence. Please note that K.A.R. 82-1-228(d)(2) requires that corporations appear through an attorney. Pursuant to K.A.R. 82-1-229, Staff may amend its prefiled direct testimony by June 29, 2012, and Respondent(s) must prefile direct testimony by July 9, 2012. One original and seven copies of prefiled direct testimony must be filed with the Executive Director of the Commission, 130 South Market, Room 2078, Wichita, Kansas 67202. Rebuttal testimony may be presented at the hearing.

If any Party(s) fails to appear and participate at this hearing, the Commission may proceed to hear evidence against the Party(s) and enter such order as shall be justified by the evidence or may result in default judgment against the Respondent pursuant to K.S.A. 77-520.

Any person requiring special accommodations under The Americans With Disabilities Act needs to give notice to the Commission at least ten (10) days prior to the scheduled hearing date.


