CURB'S INITIAL COMMENTS

COMES NOW, The Citizens' Utility Ratepayer Board ("CURB") and submits its initial comments pursuant to the schedule set forth in the State Corporation Commission of the State of Kansas ("Commission") *Order Adopting Proposed Procedural Schedule* ("Procedural Schedule") issued in this docket¹, and states as follows:

I. CURB's Initial Comments

- 1. CURB analyzed Commission Staff's four parameters recommended for review and comment, those parameters are as follows:
 - a. The types of meters that would be preferred in a meter opt-out program;
 - b. The installation costs associated with each meter type and/or billing strategy;
 - c. The operating costs associated with each meter type and/or billing strategy; and
 - d. The effects of economy of scale on the costs of an opt-out program.²

After a careful analysis, CURB determined that those four parameters are best answered by the utilities that have entered an appearance in this docket given that CURB does not have access to the necessary information to weigh in on those specific parameters for the purposes of initial comments. However, CURB reserves the right to respond to any arguments or information filed
