**NOTICE OF REQUEST TO MODIFY YEAR ONE EM&V  
REPORT AND RIDER SCHEDULE**

COMES NOW the Staff of the State Corporation Commission of the State of Kansas  
("Staff" and "Commission", respectively), and states as follows:

1. On April 10, 2025, the Commission issued an order in Docket No. 22-EKME-254-TAR granting Evergy's Motion to update its Year 1 Report and Rider Delivery Timeline. This order extended Evergy's deadlines regarding its Year 1 report filings as follows:

- a. To finalize all EM&V data collection and analyses from February 28 to March 31;
- b. To deliver draft EM&V report (present to stakeholders) from March 15 to April 15;
- c. For stakeholders to submit written comments on the EM&V report from April 1 to April 30;
- d. For a stakeholder meeting to discuss EM&V report recommendations from April 15 to May 7;
- e. For EM&V contractor to deliver its final EM&V report from May 1 to May 14; and
- f. For Evergy to file its final EM&V report with the Commission from May 1 to May 15.

2. The revised timeline maintained the standing deadlines for Evergy to file its proposed EER tariffs on June 15, for a Staff R&R on the EER proposal on August 15, stakeholder responses to Staff's R&R on September 1, and a Commission Order on October 1.

3. On June 13, 2025, Evergy Kansas Central, Inc. and Evergy Kansas South, Inc. ("EKC") filed an application in the above-captioned docket seeking Commission approval of its EER Rider to permit recovery of costs associated with EKC's various KEEIA programs.

4. On August 15, 2025, Staff filed a motion in Docket No. 22-EKME-254-TAR seeking to update the Year One EM&V Report and Rider Timeline due to ongoing sharing of information between Staff and Evergy. Staff is unable to complete its analysis at this time, as the outstanding information is integral to that analysis. Counsel for Staff has conferred with Evergy's counsel; Evergy does not oppose this request. Further, Staff counsel has conferred with counsel for CURB, which is the only other stakeholder intervened in the instant proceeding. CURB does not oppose the modification.

5. This notice filing serves to inform the record of the pending unopposed request in Docket No. 22-EKME-254-TAR to modify the schedule that controls the instant proceeding. Staff has requested until August 29, 2025, to submit its R&R in the above-captioned docket, in light of ongoing information sharing with Evergy.
