Convenience and Authority to Provide Local Exchange and Interexchange Service

Dear Ms. Retz:

Pursuant to Section 82-13-2 of the Kansas Administrative Regulations, Aero Communications, LLC ("Aero") notifies the Commission that it wishes to terminate its authority as a telecommunications provider in the state of Kansas. Specifically, Aero seeks to relinquish its Certificates of Convenience Authority to provide local exchange and interexchange services in Kansas granted on August 8, 2005 in Docket Nos. 06-AROT-038-COC (CLEC Certificate) and 06-AROT-039-COC (IXC Certificate). Aero used this authority primarily to provide secure data and voice services to banks and other financial institutions. However, Aero's business model changed and it has not served any customers in the state since 2009.

Aero also requests cancellation of its tariffs on file with the Commission. Aero has no active customers in Kansas so there will be no impact on customers. Therefore, the customer notice requirements set forth in Section 82-13-2 are not applicable. Aero has filed its annual report for 2021 and it will be its final report. Aero will pay any required assessment. There are no outstanding liens against its operating authority or any fines owed to the Commission.
