ORDER NUNC PRO TUNC

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and determination. Having examined its files and records and being fully advised in the premises, the Commission finds and concludes as follows:

- 1. On May 8, 2013, the Commission issued its Order Setting Procedural Schedule. In its Order, the Commission adopted a schedule for this proceeding, designated a prehearing officer, and approved the use of electronic service.
- 2. In paragraph 5 of the Order, the Commission discussed publication notice requirements before a public hearing. The Commission noted that Westar must publish notice of the public hearing in newspapers having general circulation in every affected county. The Commission then noted that the affected Kansas counties are Cloud and Ottawa counties.
- 3. As indicated in the caption to this proceeding, the counties affected by Westar's Application are actually *Saline* and Ottawa. Therefore, the subject sentence should have read: "The affected Kansas counties are Saline and Ottawa Counties." The reference to Cloud County and the omission of Saline County in the Commission's Order were typographical errors and should be amended as indicated above.

IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

A. The third sentence in paragraph 5 of the Commission's May 8, 2013, Order Setting Procedural Schedule is amended to read: "The affected Kansas counties are Saline and Ottawa Counties."

B. The parties have 15 days from the date of electronic service of this Order to petition the Commission for reconsideration.¹

C. The Commission retains jurisdiction over the subject matter and parties for the purpose of entering such further orders as it deems necessary.
