#### ORDER DESIGNATING NEW PREHEARING OFFICER

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed its files and records and being fully advised in the premises, the Commission makes the following findings:

- 1. On March 7, 2017, the Commission issued its *Order to Show Cause, Designating Prehearing Officer & Setting Prehearing Conference* (Order), which designated Michael Duenes as the Prehearing Officer in this proceeding.<sup>1</sup>
- 2.
