ORDER DESIGNATING NEW PREHEARING OFFICER

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed its files and records and being fully advised in the premises, the Commission makes the following findings:

1. On March 7, 2017, the Commission issued its *Order to Show Cause, Designating Prehearing Officer & Setting Prehearing Conference* (Order), which designated Michael Duenes as the Prehearing Officer in this proceeding.¹

2. The Commission designates Samuel Feather, Deputy General Counsel, 1500 SW Arrowhead Road, Topeka, Kansas 66604-4027, telephone number (785) 271-3240, s.feather@kcc.ks.gov, to serve as the new Prehearing Officer in this docket.² The Prehearing Officer may conduct prehearing conferences necessary to address any appropriate matters, including all items listed in K.S.A. 77-517(b) of the Kansas Administrative Procedure Act (KAPA). The Commission may designate other Staff members to serve in this capacity.

3. Although a Prehearing Officer is designated in this docket, parties are still required to file pleadings with the Commission, and filings shall be made with the Commission's

THEREFORE, THE COMMISSION ORDERS:


A. Samuel Feather is designated as the new Prehearing Officer.
