SUSPENSION ORDER

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. Having examined its files and records, and being duly advised in the premises, the Commission makes the following findings:

1. On November 14, 2022, Freedom Pipeline, LLC (Freedom) filed an Application with the Commission for approval of certain Gas Purchase and Sales Agreements and associated contract rates, as well as a cost analysis in establishing the rates to support a revenue requirement.
2. A full investigation of Freedom's Application, which may result in a hearing, is deemed necessary and proper. Commission Staff is without sufficient time to fully review, consider and analyze whether the proposed revisions are just and reasonable.
3. The Commission finds and concludes that suspension of the Application and deferral of its effective date are required to allow sufficient time for a full investigation into this matter. The Application should be suspended for a period of 240 days from the date the Application was filed, November 14, 2022. The Application is suspended until Tuesday, July 11, 2022 pursuant to K.S.A. 66-117(c).

IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

A. Pursuant to K.S.A. 66-117(c), Freedom Pipeline, LLC.'s Application is suspended until July 11, 2023.


B. Any party may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529 (a) (1).¹

C. The Commission retains jurisdiction over Freedom Pipeline, LLC and the subject matter of this docket for the purpose of issuing such additional orders as it may deem necessary.
