This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined its files and records, and being fully advised in the premises, the Commission finds and concludes the following:

I. Findings of Fact

1. On October 23, 2019, StrataKan Exploration, LLC, (Operator) filed an application in the captioned docket for an exception to the 10-year time limitation of K.A.R. 82-3-111 for its Harper Ranch #JC5 well.

2. On February 6, 2020, Commission Staff filed a motion to close the captioned docket, stating that the subject well has been returned to production, rendering Operator's application moot. The Commission takes administrative notice of its records and agrees with Staff's analysis.¹

II. Conclusions of Law

3. The Commission concludes it should issue an order in accordance with its findings.

THEREFORE, THE COMMISSION ORDERS:

A. Staff's motion is granted.


