**ORDER APPROVING 30-DAY EXTENSION**


On April 2, 2024, Commission Staff filed a Status Update in this docket, recommending a 30-day extension of Operator's March 31, 2024, deadline in the captioned Compliance Agreement. The Commission notes: (1) the Compliance Agreement presently addresses 19 wells, requiring Operator to obtain compliance with K.A.R. 82-3-111 at a rate of 1 well per quarter (the first deadline was December 31, 2020); (2) Operator has to date brought 13 wells into compliance with K.A.R. 82-3-111; (3) Staff recommends the extension based upon good cause shown by Operator and Operator timely making the extension request; and (4) the extension is allowed under the terms of the Compliance Agreement.<sup>1</sup>

The Commission agrees with Staff's recommendation. Operator's March 31, 2024, deadline is extended to April 30, 2024. All other deadlines in this matter remain unchanged.
