### UPDATE OF KANSAS ELECTRIC POWER COOPERATIVE, INC.

COMES NOW Kansas Electric Power Cooperative, Inc. (KEPCo) and, pursuant to the December 13, 2012 Order by the Corporation Commission of the State of Kansas (Commission) in this docket, files the following update:

- The above-referenced Order required several electric utility companies, including KEPCo, to file updates of their August, 2012, Renewable Energy Standards Report (Report) to provide the retail rate impact of the Renewable Energy Standards Act (Act).
- 2. As indicated in KEPCo's Report, submitted to the Commission and dated July 25, 2012, KEPCo has contracted with the Southwest Power Administration and the Western Area Power Administration to provide hydro power since the 1980s. Because of those contracts, KEPCo was in compliance with the requirements of the Act at the time it was passed and continues to be in compliance.
- 3. As further indicated in the Report, because the hydro power has been and continues to be KEPCo's least expensive generation resource, there has been no negative impact to revenue requirement or to the retail rates of KEPCo's members.

(See paragraphs 2, 3 and 8 of the Report). These facts have not changed since the submission of the Report.
