**ORDER ACCEPTING FILING AND CLOSING DOCKET**

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (“Commission”) for consideration and determination. Having examined its files and records, the Commission finds and concludes:

1.     On January 17, 2025, Brightspeed Companies of Kansas (Brightspeed) filed an application for tariff revision with the Commission with a requested effective date of February 1, 2025.

2.     On January 23, 2025, the Commission issued an Order Extending Deadline for Commission Action to February 24, 2025, pursuant to K.S.A. 66-2005(p).

3.     On January 27, 2025, Brightspeed filed a Supplemental Application, stating that Brightspeed is a price-cap regulated carrier and makes its filing in accordance with K.S.A. 66-2005(q)(1)(F).

4.     K.S.A. 66-2005(q)(1)(F), states that “rates for the initial residential local exchange access line and up to four business local exchange access lines at one location shall remain subject to price cap regulation and all other rates, except rates for switched access services, are deemed

price deregulated.” K.S.A. 66-2005(q)(3) states: “if the services of a local exchange carrier are classified as price deregulated under this subsection, the carrier may thereafter adjust its rates for such price deregulated services upward or downward as it determines appropriate in its competitive environment, with tariffs for such services deemed effective upon filing with the commission.”

5. K.S.A. 66-1,190 requires telecommunications public utilities doing business in Kansas to "publish and file with the commission copies of all schedules of rates, joint rates, tolls, charges, classifications and divisions of rates affecting Kansas traffic, either state or interstate, and shall furnish the commission copies of all rules and regulations and contracts between such telecommunications public utilities pertaining to any and all jurisdictional services to be rendered by such telecommunications public utilities."

3. The Commission, pursuant to K.S.A. 66-2005(q)(3), finds that this filing should be accepted and concludes that this docket may be closed.

**IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:**

- A. This docket is hereby closed.
- B. Any party may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529(a)(1).<sup>1</sup>

**BY THE COMMISSION IT IS SO ORDERED.**
