
H&B CABLE SERVICE, INC. MOTION FOR WITHDRAWAL OF

RESPONSE TO STAFF'S SECOND REPORT AND RECOMMENDATION

Comes now H&B Cable Service, Inc. ("H&B") and requests withdrawal of H&B's  
Petition for Leave to Intervene and Response to Staff's Second Report and  
Recommendation. In support thereof H&B states as follows:

1. On July 21, 2017, H&B filed its Petition for Leave to Intervene and  
Response to Staff's Second Report and Recommendation herein, asserting the rights and  
interests of H&B are at issue in this proceeding, and that no other party in this  
proceeding is able to represent the interests of H&B effectively.
2. On August 15, 2017 the Commission granted the request of H&B in  
Docket No. 17-HBCT-508-ETC for approval of relinquishment of H&B's own ETC status  
in the Chase exchange.
3. Relinquishment of H&B's ETC designation in the Chase exchange resolves  
the interests of H&B in the instant proceeding and its intervention is no longer  
necessary.



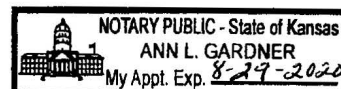


