MOTION TO CLOSE DOCKET


The Staff of the State Corporation Commission of the State of Kansas (“Staff” and “Commission,” respectively) files this *Motion to Close Docket*. In support of its Motion, Staff states as follows:

1. On March 21, 2017, Agricultural Energy Services, Inc. (Operator) submitted a license renewal application.
2. On March 24, 2017, Commission Staff denied Operator’s license renewal application because of Operator’s association with First National Oil, Inc., License #6230, which has unplugged wells on its expired, suspended license in violation of Commission regulations.
3. On June 29, 2017, Operator timely requested a hearing.
4. On August 8, 2017, Operator filed a motion for summary judgement, to which Staff timely responded December 8, 2017.¹
5. On November 16, 2017, the Commission issued an Order Setting Procedural Schedule, which was stayed pursuant to the prehearing officer’s January 11, 2018, order.
6. On January 23, 2018, the Commission granted in part and denied in part Operator’s motion for summary judgment, directing Staff to re-evaluate Operator’s application in light of the Commission’s interpretation of K.S.A. 55-155(c)(4) in its order.
7. Staff has re-evaluated Operator’s application and has renewed the license.





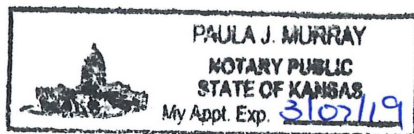
