APPLICATION

COMES NOW Quito Inc. ("Applicant") in support of its application in the captioned matter and states as follows:

1. Applicant is a corporation authorized to do business in the State of Kansas.  
Applicant's address is 1613 W 6<sup>th</sup> Street Bartlesville, Oklahoma 74003.
2. Applicant has been issued by the Kansas Corporation Commission Operator's License #33594 which expired February 28, 2023, however currently we are in the process of reinstating.
3. Applicant is the operator of the Appleby #5 well, 15-019-24284-00-00 which is in the Northeast quarter of the Northeast quarter of the Northeast quarter of Northwest quarter of Section 30, Township 33 South, Range 11 East Chautauqua County, Kansas
4. Pursuant to K.A.R. 82-3-111, the well was shut in or Applicant obtained a temporary abandonment status, for the subject well on December 11, 2013. The subject has maintained this status up to the present date.

5. On or about February 22, 2024, the Kansas Corporation Commission notified Applicant temporarily abandonment status for the subject well would be denied for and after February 22, 2024, because subject well had been temporarily abandoned for more than ten (10) years.
6. K.A.R. 82-3-111 imposes a 10-year limitation on the amount of time during which wells may be temporarily abandoned, but an exception to the 10-year limitation may be obtained pursuant to said K.A.R. 82-3-100. Applicant seeks such an exception.
7. At this time a mechanical integrity test of the casing between the surface and the point within fifty (50) feet above the uppermost perforation or open hole in the well has not been performed. A CIT tests needs to be scheduled with KCC office.
8. Applicant wishes to continue TA status for the subject well, because Applicant intends to use the well for the following purposes: future production, EOR or re-completion in a different formation.
9. Applicant submits the following information regarding the well in support of the Application in good condition, cemented to the top.
  - a. There are 8 wells on the lease: 7 oil wells and 1 SWD.
  - b. The estimated cost to plug this well is approximately \$4,500.
  - c. There is current production from Appleby well #4 from the wayside formation.
  - d. There are 3 reservoirs on this lease: The Wayside Formation, the Mississippi Chat and the Mississippi Lime. Waiting for a report from engineer.
  - e. Beyond testing, nothing further has been done at this time to the well. The well will need to be re-equipped; the electric service will need to be re-connected, and the flow lines will need to be reconnected.
  - f. The estimated cost to perform whatever actions are necessary is \$7,500.

10. Applicant has included a plat map showing the location of all producing, injection, temporarily abandoned, abandoned. And plugged wells located on the same leased premises as the subject well.

11. Based on the following, Applicant requests the Commission grant an exception to the 10-year limitation, specifically to allow the subject well to remain eligible for temporarily abandonment status for three (3) years following the expiration of the 10-year limitation. Applicant understands that the exception would be valid for three (3) years, but Applicant would still need to apply annually to the Conservation Division District Office for approval of an application for temporary abandonment status.


12. Listed in the attached Exhibit "A" are the names and addresses of the following: Operators, ~~landowners~~, and mineral Interest owners within ½ mile radius of the subject well.

13. Notice of the Application will be published pursuant K.A.R. 82-3-135a. In addition, notice of the hearing to be held on this matter will be provided as prescribed in K.A.R. 81-3-135.

WHEREFORE, Applicant prays that his matter be granted administratively without a hearing, or in the alternation be set for hearing, and upon hearing that the Commission grants Applicant's request, for an exception of the K.A.R. 82-3-111 ten (10 ) year limitation, to allow the subject well to remain temporarily abandoned for the three ( 3 ) years, subject

to annual approval by the Conservation Division District Office of an application for temporary abandonment status.


