PRESIDING OFFICER
PROPOSED DEFAULT ORDER

The Presiding Officer rules as follows:

1. On May 14, 2025, Thresher Energy filed an application as described by the above caption. On May 30, 2025, the James V. and Misti A. Wallingford Revocable Trust (Trust) filed a protest. On June 12, 2025, the Commission designated a presiding officer and set a June 26, 2025, prehearing conference. The Trust failed to attend the prehearing conference.

2. K.S.A. 77-520 provides that “If a party fails to attend or participate in a prehearing conference, hearing or other stage of an adjudicative proceeding, the presiding officer may serve upon all parties a written notice of a proposed default order, including a statement of the grounds.” Due to the Trust’s failure to attend the prehearing conference, the Presiding Officer finds the Trust has failed to participate in a stage of this adjudicative proceeding, and serves this Proposed Default Order.

3. Pursuant to K.S.A. 77-520(b), the Trust may file a written motion requesting this Proposed Default Order be vacated, stating the grounds relied upon, within seven calendar days after service of this Order. Pursuant to K.S.A. 77-520(c), unless the Trust files a timely motion to vacate this Proposed Default Order, this Order shall be effective.

4. If this default order becomes effective, then any party may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529(a)(1).¹
