follows:

1. My name is Larry J. Weians and I am Vice President, Tax. I am an officer of Sprint Communications Company LP (“Sprint”), and in that capacity I am authorized to execute this Affidavit on behalf of Sprint.

2. I provide this Affidavit in support of the response of Sprint to the Order of the Kansas Corporation Commission (Commission) dated June 24, 2021, in Docket No. 21-SCCC-065-KSF, concerning separate identification of the KUSF surcharge on customer bills.

3. As a consequence of the Commission’s Order, Sprint has implemented changes in its billing system to provide for separate line item identification of the KUSF surcharge on customer bills. That revision to the billing system was implemented in April 2021.

4. Consistent with the Commission’s Order, Sprint has provided to GVNW ten customer bills demonstrating that the KUSF surcharge has been separately broken out.

5. The foregoing is true and correct to the best of my knowledge and belief.
