Pursuant to the 34.5kV formula based ratemaking (FBR) protocols approved by the State Corporation Commission of the State of Kansas (Commission) for The Victory Electric Cooperative Association, Inc. (Victory) in Docket No. 21-SEPE-049-TAR (21-049 Docket) (the Victory 34.5kV FBR Protocols), “Entities granted intervention in 21-SEPE-049-TAR who either are or represent customers of Victory at the time of the Annual Update filing will be considered automatically approved for intervention upon the filing an Entry of Appearance in any individual Annual Update filing, provided they are not prohibited from participation by statute or otherwise”¹
