## PREHEARING OFFICER ORDER SETTING STATUS CONFERENCE

- 1. On November 22, 2017, Streamline Energy, LLC (Applicant) filed an Application to commence the disposal of saltwater into the Arbuckle Formation at the Rains #SWD well in Montgomery County, Kansas.<sup>1</sup>
- 2. On December 20, 2017, Adell T. Nellis filed a protest,<sup>2</sup> and on January 4, 2018, requested a hearing.<sup>3</sup>
- 3. On March 1, 2018, a Prehearing Conference was scheduled by the Prehearing Officer, Samuel Feather, for March 2, 2018.<sup>4</sup> A Prehearing Conference was held on March 2, 2018.
- 4. On April 26, 2018, Michael J. Duenes was designated as the new Prehearing Officer in this matter.<sup>5</sup>
