ORDER ADOPTING AUDIT REPORT AND CLOSING DOCKET

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (“Commission”) for consideration and determination. Having examined its files and records, the Commission finds and concludes:

1. On August 1, 2024, the Commission directed Vantage Point Solutions (VPS) to perform an audit of Consumer Cellular, Inc. (Consumer Cellular) for Kansas Universal Service Fund (KUSF) purposes.
2. On March 11, 2025, VPS filed its Audit Report stating it did not find any KUSF reporting deficiencies during the course of the audit. VPS recommended the Commission issue an Order adopting the Audit Report and close the Docket.
3. The Commission has reviewed the Compliance Report filed by VPS in this matter and finds it the recommendations to be reasonable and therefore concludes they should be adopted and this Docket should be closed.

IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

A. The Commission accepts and adopts Vantage Point Solutions' Audit Report filed March 11, 2025 and hereby closes this Docket.
