ORDER DESIGNATING PRESIDING OFFICER

This matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. Having reviewed the pleadings and record, the Commission makes the following findings:

1. On July 1, 2025, Atmos Energy Corporation (Atmos) submitted an application requesting approval of its 2026 System Integrity Program (SIP) Plan Year 6 pursuant to Atmos' SIP Tariff that was originally filed and approved in Docket No. 19-ATMG-525-RTS and was recently updated and approved by the Commission on May 22, 2025.¹

2. The Commission may designate a presiding officer to conduct prehearing conferences to address any matters appropriately considered in a prehearing conference, including all items listed in K.S.A. 77-517(b) of the Kansas Administrative Procedure Act (KAPA). Accordingly, the Commission designates Brian G.
