# **ORDER DENYING APPLICATION FOR LICENSE**

The above captioned matter comes before the State Corporation Commission of the State of Kansas ("Commission"). Having examined its files and records, and being fully advised in the premises, the Commission makes the following findings and conclusions:

## I. JURISDICTION

- 1. Pursuant to K.S.A. 55-155, the Commission is authorized to license operators and contractors as defined by K.S.A. 55-150.
- 2. K.S.A. 55-155 and K.A.R. 82-3-120 outline requirements of the Applicant seeking a license or renewed license.

#### II. STATEMENT OF FACTS

3. On September 28, 2017, in Docket No. 18-CONS-3154-CPEN, the Commission issued a *Penalty Order* against the Operator for violation of K.A.R. 82-3-107 and K.A.R. 82-3-130, ordering the Operator to pay a \$500 penalty and submit a complete and accurate well completion report and associated documents. The record reflects that the Operator did not request a hearing on the *Penalty Order*. Pursuant to the *Penalty Order*, if the Operator did not comply with

the provisions therein, the Operator's license was to be suspended without further notice.<sup>2</sup> The Commission takes official notice of Docket No. 18-CONS-3154-CPEN.

- 4. The Operator did not pay the \$500 penalty or submit a complete and accurate well completion report and associated documents. The Operator's license was therefore suspended on October 30, 2017, pursuant to the terms of the *Penalty Order*.<sup>3</sup>
  - 5. On January 8, 2018, the Operator submitted an Application for license renewal.
- 6. Staff did not renew the Operator's license administratively in light of the Operator's suspended license.
- 7. On March 15, 2018, the Conservation Division mailed the Operator a letter notifying the Operator of the aforementioned deficiencies in its Application and requiring the Operator's response by March 30, 2018. A copy of the letter is attached to this Order as Exhibit A and is incorporated herein by reference. To date, the Operator has not provided a response.

#### III. FINDINGS AND CONCLUSIONS

- 8. In light of the Operator's suspended license, the Commission finds the Operator's Application does not meet the requirements of K.S.A. 55-155(c)(4) and K.A.R. 82-3-120.
- 9. Pursuant to K.A.R. 82-3-120(i), the Commission's denial of the Operator's Application for license renewal constitutes a summary proceeding under K.S.A. 77-537.

## THEREFORE, THE COMMISSION ORDERS THAT:

- A. The Operator's license renewal Application is denied.
- B. Pursuant to K.S.A. 77-537 and 77-542, any party may request a hearing on the above issues by submitting a written request, setting forth the specific grounds upon which relief is sought, to the Commission's Secretary, at 266 N. Main, Suite 220, Wichita, Kansas 67202 within

fifteen (15) days from the date of service of this Order. If service is by certified mail, service is complete upon the date delivered shown on the Domestic Return Receipt. If no hearing is requested, this summary order shall become final and effective upon the expiration of the time for requesting a hearing.

C. The Commission retains jurisdiction over the subject matter and the parties for the purpose of entering such further orders as it may deem necessary.
