those customers will or may be affected by any Commission order or activity in this proceeding.

will or may be bound by any Commission order or activity in this proceeding and will or may be

adversely affected thereby.

CURB moves the Commission for an order allowing it to intervene in this proceeding and

to become a party of record with all rights to have notice of and participate in hearings, to present

evidence, to cross-examine witnesses, to file briefs and participate in argument, and for all other

necessary and proper purposes.
