Supplemental Affidavit

I, Gregory L. Brown, of lawful age, duly sworn, do state the following:

I am President of Kaw Pipe Line Company.

This Affidavit is being provided as a supplement to Kaw Pipe Line Company's Application to Cease Operation of a certain route as shown on Supplement No. 14 to KCC No. 145 with an effective date of April 1, 2018.

Kaw proposes to cancel one connecting carrier receipt (shown as Route 03) and corresponding rates at Plainville (Rooks County), Kansas on Supplement No. 14 to KCC 145 for the following reason:

Plainville truck station in Rooks County, Kansas was utilized solely by CHS McPherson Refinery Inc. ("CHS"), with destinations at Chase (Rice County), Kansas and Lyons (Rice County), Kansas.

Plainville CVR pipeline connection in Rooks County, Kansas is utilized solely by Coffeyville Resources ("CVR"), with destinations at Chase (Rice County), Kansas and Lyons (Rice County), Kansas.

The 17.25-mile Plainville to Bemis pipeline system was assessed with an In-line Inspection tool for integrity, anomalies identified, and the estimated cost of repair and risks to the environment is determined too great to justify repairing the system.

CHS began moving Plainville volumes by truck to unloading facilities at Kaw's Bemis Station (found on Supplement No. 11 to KCC 140) and to new unloading facilities at Riverview Station on the Plains Pipe Line system in November 2017. Their former needs have been met by these pipeline segments for the past 4 months.

CVR has announced that they will begin moving all Plainville volumes to a new pipeline connection with Pony Express Pipeline near Natoma (Rooks County), Kansas in March 2018. Their needs are expected to be met by this new connection.

Additional wording has been added to Route 01 of this Supplement to show the only available truck location (Palco Station) on the Kaw system in Rooks County, Kansas.

If approved, this cessation would be effective April 1, 2018.




