In the matter of the failure of Petro River Operating, LLC, to comply with Kansas Corporation Commission regulations with regard to 39 oil and gas wells in Cheyenne, Cowley, and Marion Counties, Kansas. Docket No.: 15-CONS-771-CPEN CONSERVATION DIVISION License No.: 34734

PENALTY ORDER

The above captioned matter comes before the State Corporation Commission of the State of Kansas. Having examined the files and records, and being duly advised in the premises, the Commission finds and concludes as follows:

I. JURISDICTION

1. K.S.A. 74-623 provides that the Commission has the exclusive jurisdiction and authority to regulate oil and gas activities. K.S.A. 55-152 provides that the Commission has jurisdiction to regulate the construction, operation, and abandonment of any well and the protection of the usable water of this state from any actual or potential pollution from any well. The Commission has licensing authority pursuant to K.S.A. 55-155.

2. K.S.A. 55-162 and K.S.A. 55-164 provide the Commission with authority to issue a Penalty Order regarding a violation of Chapter 55 of the Kansas Statutes Annotated, or of any rule, regulation, or order of the Commission. A Penalty Order may include a monetary penalty of up to \$10,000, and each day of a continuing violation constitutes a separate violation.

3. K.A.R. 82-3-111 provides that within 90 days after operations cease on any well, the operator of that well shall plug the well, return the well to service, or file an application with the Conservation Division requesting temporary abandonment ("TA") status. A well shall not be eligible for TA status if the well has been shut-in for 10 years or more without an application for an exception pursuant to K.A.R. 82-3-100 and approval by the Commission. The failure to file an application for TA status shall be punishable by a \$100 penalty. K.A.R. 82-3-111(e) provides an exemption for certain wells for 365 days if they are fully equipped and capable of production.

II. FINDINGS OF FACT

4. Operator conducted oil and gas activities in Kansas under license number 34734.

5. Operator is responsible for the care and control of 39 unplugged wells located in Cheyenne, Cowley, and Marion Counties, Kansas ("the subject wells").¹ A list of the wells is attached as Exhibit A. Cheyenne County is in the area supervised by District #4, and Cowley and Marion Counties are in the area supervised by District #2.

6. Operator remains in good standing with the Kansas Secretary of State. A printout of its corporate information is attached as Exhibit B.

7. Kansas Geological Survey results, attached as Exhibit C, indicate Operator produced 6,759 barrels of oil and 72,615 mcf of gas from 2011 to 2014. Based on estimated \$80 oil and \$3.5 gas over that period, these production records indicate revenue of \$794,872.50.

Pursuant to K.S.A. 55-155, Operator submitted with its license application in May
2012 a \$45,000 irrevocable standby letter of credit, insuring against noncompliance with
Commission regulations. The letter of credit automatically renews each year unless cancelled
120 days before renewal, and it remains in effect today.

Operator's license has been suspended since February 6, 2015, due to
noncompliance with KCC Docket Nos. 15-CONS-467-CPEN (five violations of K.A.R. 82-3 111 for the failure to plug inactive wells) and 15-CONS-525-CPEN (two paperwork violations of

¹ Wells with the status PA are plugged, and wells with the status RC have been recompleted, resulting in a duplicate API number. The remaining 39 wells are listed as PR (producing), IN (inactive), AI (authorized injection), and DR (drilled). District Staff has verified that all of Petro River's operations are shut-in due to license suspension.

K.A.R. 82-3-409).² The 39 subject wells still appear on Operator's license and have not been plugged or transferred to a licensed operator.

District #2 Staff recommends that the five wells in KCC Docket No. 15-CONS 467-CPEN will likely require plugging costs in excess of the amount in the letter of credit. The
11 additional wells located in District #2 will probably require similar per well plugging costs.

11. District #4 Staff recommends the 23 shallow gas wells in its area will require plugging costs slightly in excess of the amount in the letter of credit.

12. Based on District Staff's recommendations regarding plugging costs, the entire letter of credit should be collected at this time.

III. CONCLUSIONS OF LAW

13. The Commission concludes it has jurisdiction over Operator and this matter.

14. The above findings of fact are sufficient evidence to support the conclusion that the Operator has violated Commission regulations, failed to comply with Commission Orders, allowed its license to become suspended without addressing the underlying violations, and has left 39 abandoned wells unplugged with anticipated plugging costs exceeding its letter of credit.

THEREFORE, THE COMMISSION ORDERS:

A. Operator shall pay a \$10,000 penalty, and its license shall remain suspended.

B. Staff is directed to make a claim against the \$45,000 letter of credit.

C. Staff is directed to plug any of the subject wells that appear to have potential to cause pollution to usable water, and then to plug any additional abandoned wells after pollution risks are addressed, using the proceeds from the letter of credit.

² In addition, Operator's license was suspended in KCC Docket No. 14-CONS-850-CPEN (one plugging violation of K.A.R. 82-3-407) for approximately five months until the well in that docket was finally plugged on November 5, 2014.

D. Any wells remaining unplugged after the proceeds of the letter of credit are exhausted shall be prioritized for state plugging according to their potential to cause pollution.

E. The notice and opportunity for a hearing on this order shall constitute the notice required by K.S.A. 77-512 regarding license suspension. The Commission may impose further sanctions, including additional monetary penalties and any other remedies available to the Commission by law, without further notice.

F. Checks and money orders shall be payable to the Kansas Corporation Commission. For credit card payments, include the type of card (Visa, MasterCard, Discover, or American Express), account number, and expiration date. Payments shall be mailed to the Kansas Corporation Commission at 266 N. Main, Ste. 220, Wichita, Kansas 67202. <u>The</u> <u>payment must include a reference to the docket number of this proceeding</u>.

G. Any party may request a hearing on the above issues by submitting a written request, pursuant to K.S.A. 55-164, K.S.A. 77-537, and K.S.A. 77-542, setting forth the specific grounds upon which relief is sought, to the Commission at 266 N. Main, Ste. 220, Wichita, Kansas 67202, within 30 days from the date of service of this Order. Hearings will be scheduled only upon written request. Failure to timely request a hearing will result in a waiver of Operator's right to a hearing.

H. If a party requests a hearing, a corporation or similar entity shall not be permitted to enter an appearance except by its attorney. Attorneys for all parties shall enter their appearances in Commission proceedings by giving their names and addresses for the record.

I. The Commission retains jurisdiction over the subject matter and the parties for the purpose of entering such further order or orders as it may deem necessary.
