APPLICATION

Pursuant to K.S.A. 66-1,177, et seq., ITC Great Plains, LLC ("ITC Great Plains" or "Company") hereby respectfully requests a siting permit conferring on ITC Great Plains the right to construct a double-circuit 345-kV transmission line from the Spearville Substation south to a new substation in Clark County, Kansas, and continuing east to a new substation in Barber County near Medicine Lodge, Kansas ("V-Plan"). For its request, ITC Great Plains submits the following:

I. BACKGROUND

1. ITC Great Plains is a public utility under the provisions of K.S.A. 66-104, pursuant to the Commission's Order Approving Stipulation and Agreement and Addressing Application of Statutes, In the Matter of the Application of ITC Great Plains, LLC for a Limited Certificate of Public Convenience to Transact the Business of an Electric Public Utility in the State of Kansas, Docket No. 07-ITCE-380-COC (Kan. Corp. Com'n, June 5, 2007).

2. On April 11, 2008, ITC Great Plains filed an application to amend its certificate of public convenience to build the V-Plan line. See In the Matter of the Application of ITC Great Plains, LLC to Amend its Certificate of Public Convenience and Authority to Transact the Business of an Electric Public Utility in the State of Kansas, Docket Nos. 08-ITCE-936-COC, 08-ITCE-937-COC and 08-ITCE-938-COC (consolidated on December 18, 2008 into Docket No. 08-ITCE-936-COC, "936 docket") (Kan. Corp. Com'n). On October 5, 2009, the Commission granted ITC Great Plains' request to amend its certificate of public convenience to construct its portion of the V-Plan line in its Order Granting Joint Motion to Approve Stipulation and Agreement and Denying CURB's Objection.¹

3. On June 30, 2010, a Second Stipulation and Agreement was filed in Docket Nos. 08-ITCE-936-COC and 08-PWTE-1022-COC to reflect the Southwest Power Pool, Inc.'s ("SPP") decision to approve construction of the V-Plan line at 345 kV and not 765 kV, as contemplated in the initial June 1, 2009 Stipulation and Agreement. The Second Stipulation and Agreement allocated responsibility for construction of the V-Plan project at the lower voltage. The Commission approved the Second Stipulation and Agreement in its July 29, 2010 Order Granting Joint Motion to Approve Second Stipulation and Agreement. The instant Application reflects the terms and conditions of the Second Stipulations and Agreement.

¹ ITC Great Plains' V-Plan dockets were considered concurrently with an application to build a similar line filed by Prairie Wind Transmission, LLC ("Prairie Wind"), Docket No. 08-PWTE-1022-COC. Westar Energy, Inc. owns a 50% membership interest in Prairie Wind. The remaining 50% membership interest in Prairie Wind is owned by Electric Transmission America, LLC. ETA is a joint venture between AEP Transmission Holding Company, LLC, a wholly-owned subsidiary of American Electric Power Company, Inc., and MEHC America Transco, LLC, a wholly-owned subsidiary of MidAmerican Energy Holdings Company. In its October 5, 2009 Order, the Commission, among other things, granted ITC Great Plains' request for an amended certificate of convenience to construct its portion of the V-Plan project and granted Prairie Wind's request for a certificate of convenience to construct its portion of the V-Plan project, all as specifically set out in the June 1, 2009 Stipulation and Agreement.

6. In this Application, ITC Great Plains seeks a siting permit authorizing it to construct an approximately 120-mile, double-circuit 345-kV transmission line from the Spearville Substation south to a new substation in Clark County, Kansas (the "Clark County Substation"), and continuing east to a new substation in Barber County, Kansas (the "Thistle Substation"), near Medicine Lodge. It is designed to connect eastern and western Kansas to improve electric reliability and enable energy developers to tap into the transmission grid, further establishing a competitive energy market in the state. This will contribute to a stronger transmission grid that will benefit the entire region. Kansans will enjoy a robust grid that will increase reliability. The V-Plan will facilitate the development and export of wind generation from central and western Kansas while providing access to reliable and diverse sources of energy across the state and region. It will also ease congestion across the transmission network, addressing the lack of high-voltage transmission lines in central and western Kansas, which causes inefficiencies in the grid and does not allow power to flow in the most efficient manner.

7. The V-Plan is one of SPP's "Priority Projects" – a group of high voltage electric transmission projects designed to relieve grid congestion, improve the delivery of power to customers, facilitate the addition of new renewable and non-renewable generation to the electric grid, make more efficient use of the transmission system, and maintain electric reliability. A report describing these projects was approved by the SPP Board of Directors in April 2010. The attached Direct Testimony of Alan K. Myers further explains the need for and benefits of the V-Plan. On June 30, 2010, SPP issued its Notifications to Construct ("NTC") to both Sunflower Electric Power Corporation ("Sunflower") and Mid-Kansas Electric Company, LLC ("Mid-Kansas"), the Transmission Owners designated to build the V-Plan per Attachment O, Section VI of SPP's OATT (copies of the NTCs are attached hereto as **Exhibits 1 and 2**). On September 3, 2010, Sunflower and Mid-Kansas each sent letters to SPP accepting the obligation to construct their respective portions of the V-Plan, and each designating ITC Great Plains to construct and own the project (copies of the responsive letters are attached hereto as **Exhibits 3 and 4**).

8. ITC Great Plains estimates that it will cost approximately \$300.2 million to construct its segments of the V-Plan. This is a preliminary estimate based on current costs of labor and materials and the cost to acquire needed right-of-way. The actual costs of construction may differ from this estimate and will be affected by, among other things, changes in commodity prices, labor rates and right-of-way costs.

9. ITC Great Plains employed Black & Veatch to assist in selecting a route. After initial mapping, inspection and a series of open houses through which it received input from landowners and residents in the areas along potential routes, ITC Great Plains chose the proposed route. ITC Great Plains also sought and received input from state and federal agencies and public interest groups. All of the information received from these contacts was used to

identify a route that minimizes adverse social and environmental impacts of the line. The attached Direct Testimony of Salvatore Falcone details the route selection process.

10. The proposed route for the V-Plan crosses through the retail electric service territory of certain Kansas retail electric suppliers. Should the Commission approve this Application, ITC Great Plains will request approval from the Commission under the Retail Electric Suppliers Act, K.S.A. 66-1,170, et seq., to traverse the retail service territory of these other electric service providers. ITC Great Plains will also submit a wire stringing application pursuant to K.S.A. 66-183 and K.A.R. 82-12-1, et seq., after design of the line is complete.

11. ITC Great Plains has identified its proposed route based on the results of its routing study report and its anticipated interconnection with Prairie Wind's facilities. Given the likelihood of changes to the route proposed by affected landowners, ITC Great Plains requests that the Commission approve the proposed route but give the Company flexibility to adjust the route as needed to accommodate minor modifications proposed by landowners and/or to interconnect with Prairie Wind.

II. PROPOSED FACILITIES

A. Overview

12. ITC Great Plains' segments of the V-Plan will extend approximately 120 miles in length. <u>See</u> Exhibit 1 attached to the Direct Testimony of Carl A. Huslig for a map of the route. ITC Great Plains is responsible for design, construction and operation of the double-circuit 345kV V-Plan segments from the Spearville Substation south to the new Clark County Substation, then east to the new Thistle Substation. Prairie Wind is responsible for the design, construction and operation of the double-circuit 345-kV V-Plan segment from the Thistle Substation to the Wichita Substation. Prairie Wind is also responsible for the design, construction and operation of a double-circuit 345-kV line from the Thistle Substation to interconnect at the Kansas/Oklahoma border with a transmission project that will continue into Oklahoma to the Woodward Substation.

B. Transmission Facilities

ITC Great Plains' portion of the V-Plan will be a double-circuit 345-kV line 13. designed for 1,800 MVA per circuit. The substation equipment ratings will be no less than 3,000 amperes. The V-Plan is expected to be built primarily with double-circuit steel monopole structures, subject to final detailed engineering design. Double-circuit steel monopole structures will minimize the impact on agricultural land use. The tangent, angle and dead-end structures will be supported on drilled concrete piers. The height of the structures will vary based on terrain, clearances to ground, objects under the line and structure spacing, but will typically range between 120 and 160 feet. The span lengths between structures will be approximately 800 to 1,500 feet, with an average span of 900 feet. Structure placement and span lengths will be adjusted, if possible, in cultivated fields to minimize interference with the operation of center pivot irrigation systems. The transmission line will be constructed with steel reinforced aluminum conductors. The conductors will be arranged in a two-conductor bundle for each of the three phases of the individual circuits. The two conductors will be arranged in a vertical pattern with the conductors spaced 18 inches apart. The individual phases will be attached to the monopole by a davit arm. Two overhead ground wires will be located at the top of the structure to protect the conductors from a lightning strike. An I-string assembly will be used for most of the larger angles that do not require dead end assemblies. Insulator assemblies will be equipped with metal rings to minimize corona. Insulators will be polymer type.

14. Construction of the line will consist of clearing, structure assembly, structure erection, stringing and tensioning of conductors and shield wires, energizing the line and cleanup/restoration. Timber within the right-of-way will be removed or trimmed as necessary to assure reliability and safety of the line. All conductors and shield wires will be tension strung. Use of this method will ensure that the conductor will not touch the ground or other objects during construction. Care in handling the conductor will keep its surface smooth, thereby minimizing corona and associated radio-TV interference and audible noise.

15. Structures will be assembled in the field. All structures will be self supporting, un-guyed structures. The construction crew will consist of 50 to 100 workers at its peak level, using heavy equipment that includes hole diggers, cranes, stringing rigs, conductor tensioners, back hoes, trucks, cars and other items.

16. Wire fences, metal gates and other permanent metallic objects within or near the transmission line right-of-way will be grounded, as required, to limit the electromagnetically induced levels of static charges to safe levels. The minimum conductor to ground clearance will be established in accordance with the requirements of the National Electrical Safety Code. The minimum clearances will be increased to limit the steady state current due to electrostatic effects to less than 5 milliamperes on the largest truck, vehicle or equipment anticipated to be operated under the transmission line.

17. Construction equipment and other vehicles will travel along the right-of-way, where possible, and the need for access roads to the work areas will be minimal. Cut and fill operations to facilitate construction activities will not be required for this project. ITC Great Plains will apply for a construction activity, National Pollutant Discharge Elimination System ("NPDES") permit from the Kansas Department of Health and Environment ("KDHE"),

pursuant to the provisions of K.S.A. 65-164 and 65-165, and the Federal Water Pollution Control Act, as amended, 33 U.S.C. 1251 et seq.

18. Before starting construction, ITC Great Plains will develop and submit a stormwater pollution prevention plan ("SWPPP"). The purpose of the SWPPP is to ensure the design, implementation, management and maintenance of "best management practices" ("BMPs") in order to reduce the amount of sediment and other pollutants in stormwater runoff from the construction site. ITC Great Plains, its representative and/or the contractor(s) responsible for installation, operation and maintenance of the BMPs, will have a current copy of the SWPPP with them during construction. ITC Great Plains will ensure the construction site is inspected on a regular schedule and within 24 hours after a 0.5-inch storm event. A report of each inspection will be prepared, and KDHE will be notified, when final stabilization of the site is complete. ITC Great Plains will inspect the construction and clean up operations to assure compliance with specifications and standard procedures.

19. Maintenance inspections will be performed by walking, driving or flying along the line route. In the event that heavy equipment is required for regular maintenance or for repair of storm damage, restoration procedures will be the same as those employed at the time of construction.

III. RIGHT-OF-WAY REQUIREMENTS

20. The nominal width of the right-of-way will be 200 feet to allow for the design and construction of the line for operation at 345 kV. However, it could be more or less in specific areas depending on span length, conductor sag, wind characteristics and adjacent vegetation. Where the line is located adjacent to an existing transmission line, distribution line or road, the

width of new right-of-way may be reduced based on sharing or overlap of the existing easement or right-of-way.

21. An affected landowner will most likely be able to use the right-of-way for any agricultural purpose, but will not be permitted to conduct business which would be hazardous to the landowner, the line or to the general public. No foreign structures will be permitted in any part of the right-of-way. Trees and brush in the right-of-way that intrude into the clearance areas will be cut back by means of topping or feathering. Herbicides will be used to control weeds around poles unless such treatment is not desired by the landowner.

22. Easements will be procured from landowners prior to construction. Landowners will be compensated for all damages, including crop losses, that are directly attributable to construction.

IV. PROJECT SCHEDULE

23. The V-Plan will consist of the construction of an approximately 120-mile transmission line from the Spearville Substation south to the new Clark County Substation, and continuing east to the Thistle Substation in Barber County, Kansas, near Medicine Lodge. The current SPP NTCs issued on June 30, 2010 require that the V-Plan will be completed no later than December 31, 2014. Surveying associated with the acquisition of easements will be done in conjunction with acquiring the easements. Upon approval of this Application, we anticipate these activities would start mid 2011 and continue until spring 2013.

V. SITING AND ENVIRONMENTAL

24. A description of siting activities and ITC Great Plain's approach to issues surrounding siting, such as environmental issues, are provided in the attached Direct Testimony of Salvatore Falcone.

VI. LANDOWNER LIST

25. A list of the names and addresses of the landowners of record whose land or interest therein ITC Great Plains proposes to acquire in connection with the construction of the V-Plan, or is located within 1,000 feet² of the center line of the easement where the line is proposed to be located, is included with this Application as **Exhibit 5**.

WHEREFORE, based on the above and foregoing, ITC Great Plains respectfully requests that the State Corporation Commission of the State of Kansas: (i) grant ITC Great Plains a siting permit conferring on ITC Great Plains the right to construct a double-circuit 345-kV transmission line from the Spearville Substation south to the new Clark County Substation, and continuing east to the new Thistle Substation in Barber County, Kansas, near Medicine Lodge; and (ii) grant such other and further relief as may be appropriate.

 $^{^2}$ Pursuant to K.S.A. 66-1,178(a)(2), an electric utility seeking to site a transmission line is required to notify "landowners of record whose land or interest therein is proposed to be acquired in connection with the construction of or is located within 660 feet of the center line of the easement where the line is proposed to be located." In order to accommodate minor modifications to the proposed route, ITC Great Plains is exceeding the requirements of the statute.
