## STATUS UPDATE TO COMPLIANCE AGREEMENT

On October 8, 2019, the Commission issued an Order Approving Compliance Agreement (Agreement) in this docket. On October 21, 2020, Operator requested an extension of time from its November 1, 2020, deadline in order to plug, return to service, or repair and TA the well(s) subject to this deadline. Commission Staff's District #2 Supervisor believes Operator has demonstrated financial and environmental related good cause for making its request and recommends approval of Operator's request to extend its November 1, 2020 deadline to December 1, 2020.

Staff would note Operator is currently in compliance with their agreement and recommends approving Operators request for an extension of time.
