## ORDER ADOPTING AUDIT REPORT AND CLOSING DOCKET

The above-captioned matter comes before the State Corporation Commission of the State of Kansas ("Commission") for consideration and determination. Having examined its files and records, the Commission finds and concludes:

- 1. On August 1, 2024, the Commission directed Vantage Point Solutions (VPS) to perform an audit of GBT Communications, Inc. (GBT) for Kansas Universal Service Fund (KUSF) purposes.
- 2. On January 24, 2025, VPS filed its Audit Report making findings for GBT in Operating Year 27. VPS recommended GBT take certain corrective actions to remedy issues discovered during the course of its audit.
- 3. The Commission issued an Order on January 30, 2025, adopting the recommendations of VPS.
- 4. On May 14, 2025, VPS issued a Compliance Report indicating GBT had complied with the Commission's Order issued January 24, 2025. VPS stated GBT had fulfilled all the

requirements of the Order and was in compliance with Commission directives and recommended that the Docket be closed.

5. The Commission has reviewed the Audit Report filed by VPS in this matter and finds the recommendations to be reasonable and therefore concludes they should be adopted and this Docket should be closed.

- A. The Commission accepts and adopts Vantage Point Solutions' Audit Report filed May 14, 2025, and hereby closes this Docket.
