- 1. On March 20, 2018, Urban Oil and Gas Group LLC (Operator) filed an Application seeking authorization for injection of saltwater into the Arbuckle formation at the Lygrisse #82X well in Sedgwick County, Kansas.¹
- 2. On April 6, 2018, Benjamin M. Giles (Protestant) filed a letter of protest, and on May 7, 2018, requested a hearing.²
- 3. On September 20, 2018, a procedural schedule was established, setting deadlines in October and November 2018 for pre-filed testimony.³
- 4. Due to significant unforeseen circumstances, the parties agreed via email that the proceedings should be stayed, with a Status Conference scheduled for a date at the end of October 2018.
