**DAYLIGHT PETROLEUM, LLC’S MOTION TO
DISMISS / MOTION FOR SUMMARY JUDGMENT**

Daylight Petroleum, LLC by and through its attorney, Keith A. Brock, hereby files this Motion to Dismiss / Motion for Summary Judgment, pursuant to K.S.A. 77-519(a). In support hereof, Daylight Petroleum, LLC states:

I. NO DISPUTE OF MATERIAL FACT

1. There are no disputed facts involved in this Docket which would require a hearing to be held in this matter.

2. The uncontroverted material facts involved in this Docket are as follows:

a. On November 4, 2024, Bluejacket Operating, LLC (“Bluejacket”) obtained a license from the Commission, and satisfied all financial assurance requirements set forth by applicable law. *See* Staff’s Motion for the Designation of a Presiding Officer and the Scheduling of a Prehearing Conference (“Staff’s Motion”), ¶ 1.

b. Between November 8 and November 20, 2024, Staff received Request for Change of Operator (“T-1”) Forms for approximately 55 leases, which transferred the leases from Daylight Petroleum, LLC (“Daylight”) to Bluejacket. The submitted T-1 forms include 228 of Daylight’s 240 wells. However, the T-1 forms do not include 11 wells on the Johnson lease or the Olnhausen Farms #6 well which are all located in Section 16, Township 30 South, Range 16 East, Wilson County,

Kansas. *See* Staff's Motion ¶ 1.

c. The Johnson lease and Olnhausen Farms #6 well are currently referenced in Docket 25-CONS-3040-CMSC in which Staff asserts that an unplugged abandoned well is located beneath a building on the Johnson lease. *See* Staff's Motion ¶ 1.

d. Staff initially approved the T-1 transfers from Daylight to Bluejacket but subsequently revoked its approval and unilaterally returned all 288 wells to Daylight's well inventory. *See* Staff's Motion ¶ 2.

e. The basis relied upon by Staff in revoking its approval of the T-1 transfers from Daylight to Bluejacket and unilaterally returning all 288 wells to Daylight's well inventory, are as follows:

A concern that Daylight Petroleum, LLC is divesting itself of all of its wells in Kansas leaving no assets and only liabilities.

A concern with Bluejacket being a newly formed corporation in Kansas with no history of operating within the state.

A concern with transferring injection authority where there are unplugged wells in surrounding area.

See Staff's Response to Information Request attached hereto, Request No. 1.

f. Staff has no notes, field reports, investigations, memorandums or other documents of any kind which identifies any errors in the T-1 forms, or a single regulatory issue with any of the wells listed thereon. *See* Staff's Response to Information Request attached hereto, Request No. 3 & 4 and Documents Produced by Staff in its Supplemental Response.

g. Staff has no documents, or communications which identifies any

unplugged wells which caused concern with transferring injection authority from Daylight to Bluejacket. *See* Staff's Response to Information Request attached hereto, Request No. 3 & 4 and Documents Produced by Staff in its Supplemental Response.

h. In all of Staff's work papers, files and communications the following is the only exchange which provides an explanation for Staff's decision to initially delay and to subsequently revoke Staff's approval of the T-1 transfers from Daylight to Bluejacket and unilaterally return all 288 wells to Daylight's well inventory:

II. **THIS DOCKET MUST BE DISMISSED AS A MATTER OF LAW**

3. K.S.A 55-150 and K.A.R. 82-3-120 set forth the objective legal standards which must be met in order to receive an operator's license from the Commission.

4. Bluejacket has met all statutory and regulatory criteria necessary to receive a valid operator's license from the Commission and to operate in this state and has been issued a valid license by the Commission.

5. Staff's Motion essentially makes the assertion that despite Bluejacket meeting the legal criteria to operate oil and gas wells in the state of Kansas, the Commission can/should decide on an *ad hoc* basis (without applying applicable objective regulatory or statutory criteria) whether Bluejacket should in fact be permitted to actually operate wells in this state. This request seeks an order that would be unenforceable under the Kansas Judicial Review Act. In addition, the requested action would also subject the Commission to monetary liability in the form of a federal civil rights claim for violation of Daylight and Bluejacket's right to substantive due process and equal

protection. *See* 42 U.S.C. § 1983.

6. Daylight sold the 55 leases listed on the subject T-1 forms to Bluejacket and consideration was paid for such leases. All of the wells on these leases were in compliance with all applicable rules and regulations and T-1's were submitted notifying the Commission that operator responsibility for the subject wells has been transferred from Daylight to Bluejacket.

7. Staff expressly states two concerns in Staff's Motion,

i) "The request to transfer this magnitude of wells raises several red flags to Staff. First, Bluejacket is a new operator who only just formed in Kansas last October and only just obtained a KCC license last November. There has been no indication that Bluejacket has the resources needed to maintain its regulatory obligations regarding the 228 wells it is currently seeking to add to its license."

ii) "Second, it appears possible that if the T-1 forms are processed, then Daylight could leave behind its regulatory obligations at the Johnson lease and at the Olnhausen Farms #6 well."

Neither of these concerns provide any legal justification or authority to delay the approval of the T-1 forms which were filed. First, Bluejacket has met all financial assurance requirements imposed by applicable statute and regulations. Thus, the Commission cannot simply disregard these legal standards and subjectively determine whether Bluejacket has the resources to maintain its regulatory obligations. Second, the Johnson Lease and the Olnhausen Farm #6 well are not among the wells listed on the T-1's which are the subject of this Docket and thus cannot be used as a basis for denying the T-1's at issue in this Docket.

8. Moreover, Daylight voluntarily and proactively initiated Docket 25-CONS-3040-CMSC in order to determine what is legally required with respect to the Olnhausen Farm #6 Well and has diligently pursued such docket. Therefore, there is no evidentiary basis for Staff's assertion that Daylight is attempting to leave any unfulfilled regulatory obligations behind in the state of Kansas. In addition, the Commission's authority when sitting in a quasi-executive capacity is to

enforce the law as written, and not to impose additional requirements or criteria not found in the law. Daylight and Bluejacket have constitutionally protected property rights in the wells, leases and authorities involved in this transaction and the Commission has no authority to infringe upon those rights arbitrarily as it is doing in this Docket.

9. The Commission is bound to apply the law as it is written and also to follow the procedures proscribed by the Commission and the Kansas Legislature. *See* K.S.A. 77-621.

10. Applicable law clearly does not permit the Commission to refuse approvals that both Daylight and Bluejacket are legally entitled to, simply because Staff “currently has ongoing litigation with Daylight” on unrelated leases. These actions are arbitrary, and capricious and unlawful. *See* K.S.A. 77-621.

11. Applicable statutes and regulations create a clear and objective standard, and it is the Commission’s legal obligation to enforce such laws not to circumvent or disregard them. *See* K.S.A. 77-621(c)(1)&(4)&(5).

12. *In re DB Energy, LLC*, 23-CONS-3109-CPEN, the Commission stated that it had no qualms with Staff assessing the regulatory status of the wells listed on T-1 Forms, before approving the same. The Commission went on to state that in such instances prompt enforcement action through initiation of a docket proceeding is desirable and encouraged “where staff is concerned with a potential lack of regulatory compliance and such concerns are not quickly resolved.” *See* Final Order ¶ 34. However, in this instance, there are no allegations that any of the wells which have been transferred from Daylight to Bluejacket are out of regulatory compliance, and the documents produced in response to discovery requests issued in this Docket confirm that Staff has no evidence that any of the wells which have been transferred are out of regulatory compliance.

13. For the reasons set forth herein, there is no legal basis upon which the Commission

can take the action requested by Staff's Motion and must as a matter of law dismiss this Docket and order that the T-1 transfers from Daylight to Bluejacket be approved, and the wells listed thereon be transferred to Bluejacket's well inventory.

III. THE TRANSFER OF OPERATOR FORM T-1 IS SIMPLY A NOTICE THAT A TRANSFER OF OPERATOR RESPONSIBILITY HAS OCCURRED

14. A Transfer of Operator form T-1 ("T-1") is not the operative document which legally transfers operator responsibility from one operator to another, instead it merely notifies the Commission that operator responsibility has been transferred through other legal means. K.A.R. 82-3-136, entitled "Transfer of Operator Responsibility" provides,

(a) **If operator responsibility is transferred**, the past operator **shall report this transfer** to the conservation division **within 30 days of the change** upon a form prescribed by the commission.

(b) The past operator shall furnish a list of all active and inactive wellbores on the lease, unit, gas storage facility, or secondary recovery unit with the **notice of transfer**.

(c) Transfers shall not be made to any individual, partnership, corporation, or municipality not currently licensed as an operator, gas gatherer, or gas storage operator.

(d) Within 90 days of any transfer, the new operator shall change the tank battery identification sign provided for in K.A.R. 82-3-126 to show the new operator information.

(e) Violations of this regulation shall be punishable by a penalty of up to \$ 1,000 for the first violation, \$ 2,000 for a second violation, and \$ 3,000 plus license review for a third violation.

(Emphasis added). Pursuant to K.A.R. 82-3-136 the T-1 is merely a "notice of transfer" which is filed *after* the legal transfer of operator responsibility is carried out through an assignment, operating agreement, farm-out agreement or other legal document.

15. Even if an operator failed to comply with K.A.R. 82-3-136, the recourse would be a

monetary penalty pursuant to K.A.R. 82-3-136(e) for failure to provide adequate notice that operator responsibility had been transferred. However, since the T-1 is merely a "notice of transfer" given to the Commission after the fact, the failure to file a T-1 cannot render the legal transfer of operator responsibility (i.e. the document which transfers physical operation and control) ineffective. Nor does the Commission have any legal right to exercise any right to approve or deny a T-1 Transfer.

16. In Quest Cherokee, LLC, Docket No. 07-CONS-155-CSHO (July 16, 2008) the Commission recognized the T-1 as a notice given to the Commission after a legal transfer of operator responsibility has taken place. In the Quest Case the Commission ordered a generic docket be opened to, among other things, "examine . . . (3) the methods industry participants use to transfer legal responsibility for oil and gas wells and leases in Kansas, as well as the methods used to report these transfers to the Commission. . . ."

17. Moreover, *John M. Denman Oil Co., et al. v. The State Corporation Commission of the State of Kansas*, 12 CV 402 (Dist. Ct. Shawnee County, KS, October 10, 2013), was a judicial review proceeding wherein, commission Staff was making arguments similar to those it asserts here, i.e. that the T-1 was the operative document that transferred well responsibility from one person to another. In this judicial review proceeding the Court concluded that a person's status as an "operator" cannot be "derived merely from the Commission's T-1 form, which is derivative of merely a notification statute (K.S.A. 55-155(f))." P. 56. K.S.A. 55-155(f) provides as follows,

(f) If an operator transfers responsibility for the operation of a well or gas gathering system or for underground porosity storage of natural gas to another person, such operator shall file a **notice of transfer of operator** with the commission in accordance with rules and regulations of the commission. The **commission shall, upon receipt of such notice**, send a copy of such notice to the surface owner, as well as the contact information, including name, address, phone number, fax or email address, for a designated representative of the operator. The commission need not send such information if the operator verifies that the notice filed with the commission has been delivered to the surface owner. The commission need not send

a copy of notice to the surface owner for transfers of responsibility for the operation of a gas gathering system or for underground porosity storage of natural gas to another person.

(Emphasis added). The plain language of this statute, clearly states that the T-1 is a notice given after a transfer of operator responsibility occurs. K.S.A. 55-155(f) further mandates that the Commission "SHALL" act upon the T-1 "**upon receipt**" of the same. There is no authority for Staff to exercise discretion in approving or rejecting T-1s or to simply hold them without action. Applicable statutes and regulations make it clear that Staff's roll in processing T-1 notices is to simply update its records regarding operator responsibility and send surface owner notifications if necessary.

18. Daylight transferred operator responsibility for the subject leases and all wells located thereon, on November 8, 2024 by and through the Assignment of Oil and Gas Leases to Bluejacket. The subsequently filed T-1 forms submitted by Daylight were merely its attempt to comply with K.A.R. 82-3-136 by notifying the Commission that operator responsibility for these leases and wells had already been transferred to Bluejacket by assignment on November 8, 2024.

WHEREFORE, Daylight Petroleum, LLC respectfully requests the Commission dismiss this Docket, finding as a matter of law that the T-1 transfers must be approved and ordering Staff to process said T-1 transfers forthwith and assign the wells listed thereon and applicable injection authorities to Bluejacket.

The four key things that show we are committed are the following:

- Retained liability – we excluded the Johnson Lease wells and the Olnhusen Farms #6 well from the sale to Bluejacket (Ranch Oil). We are retaining that liability.
- Proof of action – In our March 2024 sale of the Woodson County producers we retained 7 wells and have plugged all 7. We began plugging operations on those wells in December and have plugged all 7 wellbores and are finalizing the surface cleanup as weather allows.
- Retained staff – we have retained our Kansas production foreman, who is now based out of our Lindsay, OK office and our Regulatory Admin who works remote based out of Iola, KS. Our former Kansas Production Foreman will remain as our operations coordinator for any future KS activity.
- Renewed our operator license with the KCC for 2025

My client sent me the following concerning the background of the new operator and the assurances that they will take care of whatever regulatory issues are needed in Kansas. One big issue that they do not mention that is in my mind a very significant issue is that Daylight is still a going concern and has considerable operations in other states. They are not shutting down, or slowing down, they are simply divesting this particular asset which is the only asset that exists in Kansas. They are not judgment proof by any means and certainly have a need and incentive to ensure that they are in good standing in every state which may present an opportunity in the future.

The company that I had mentioned is Ranch Oil out of Denver. Here's the bio from the president of Ranch Oil: <https://www.linkedin.com/in/richard-dean-022727200/> It states that they are a 2nd generation oil production company, and that they own and operate wells in California, North Dakota, Wyoming and Nebraska. They are expanding into Kansas and began with acquiring our wells.

The four key things that show we are committed are the following:

- Retained liability – we excluded the Johnson Lease wells and the Olnhausien Farms #6 well from the sale to Bluejacket (Ranch Oil). We are retaining that liability.
- Proof of action – In our March 2024 sale of the Woodson County producers we retained 7 wells and have plugged all 7. We began plugging operations on those wells in December and have plugged all 7 wellbores and are finalizing the surface cleanup as weather allows.
- Retained staff – we have retained our Kansas production foreman, who is now based out of our Lindsay, OK office and our Regulatory Admin who works remote based out of Iola, KS. Our former Kansas Production Foreman will remain as our operations coordinator for any future KS activity.
- Renewed our operator license with the KCC for 2025

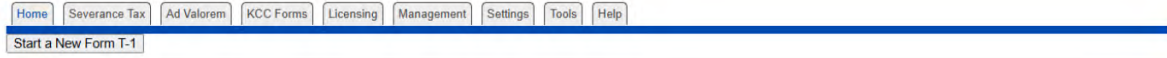
