ORDER RESCINDING ORDER ASSESSING COSTS

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and determination. Having examined its files and records and being fully advised in the premises, the Commission finds and concludes as follows:

1. On October 19, 2018, United Telephone Companies of Kansas, d/b/a Century Link (CenturyLink) filed its application for revisions to introduce the Two-Year Bundle Option (Application).¹

2. On October 30, 2018, the Commission issued an Order Assessing Costs to CenturyLink.²

3. The Order Assessing Costs shall be rescinded and CenturyLink will not be assessed any costs in this docket.

IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

A. The Order Assessing Costs issued on October 30, 2018, is hereby rescinded.

B. The parties have fifteen (15) days, plus three days if service of this order is by mail, from the date of service of this Order to petition the Commission for reconsideration or request a hearing, as provided in K.S.A. 77-542.³
