ORDER GRANTING EXTENSION

- 1. On March 19, 2015, the Commission issued its Order Reducing Saltwater Injection Rates.
- 2. On October 29, 2015, the Commission issued its Order Extending Monitoring Period.
- 3. On February 19, 2016, the Commission Staff filed a Report and Recommendation, requesting the Commission issue expanded injection requirements.
- 4. On March 3, 2016, SandRidge Exploration & Development, LLC ("Sandridge"), and Tapstone Energy, LLC ("Tapstone"), each filed a motion for an extension of time to file a response to Staff's Report and Recommendation. Each motion stated that the parties had been consulted and had no objection to an extension.
- 5. K.A.R. 82-3-218 provides 10 days for a party to respond to a pleading, with three days added to account for the mail pursuant to K.A.R. 82-3-217. The regulatory deadline for responses to Staff's Report and Recommendation was March 3, 2016. The parties request an extension of eight days, until March 11, 2016, to file responses.
- 6. The Commission finds that the motions for an extension of time filed by SandRidge and Tapstone should be granted.

7. Responses to Staff's Report and Recommendation shall be filed by SandRidge and Tapstone on or before March 11, 2016.

THEREFORE, THE COMMISSION ORDERS:

- A. The motions by SandRidge and Tapstone for an extension of time to file responses to Staff's Report and Recommendation are granted, and the deadline is extended shall be extended from March 3, 2016, to March 11, 2016.
- B. The Commission retains jurisdiction over the subject matter and parties for the purpose of entering such further orders as it may deem necessary.
